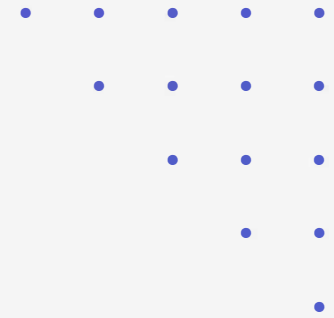

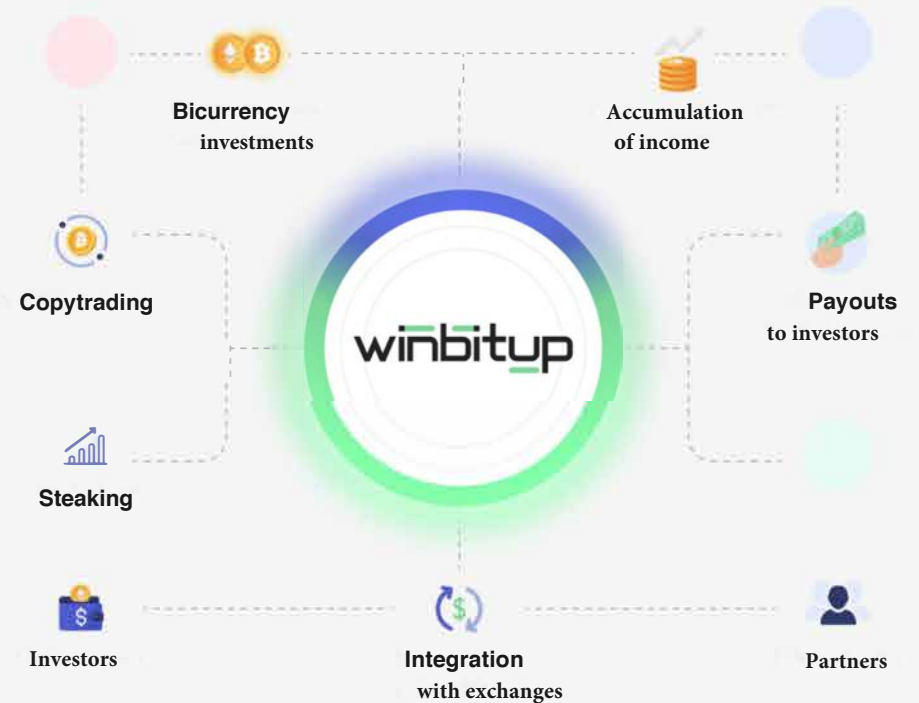

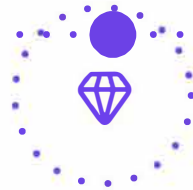
The main task of our team is to provide quality and reliable services to our clients at any time.

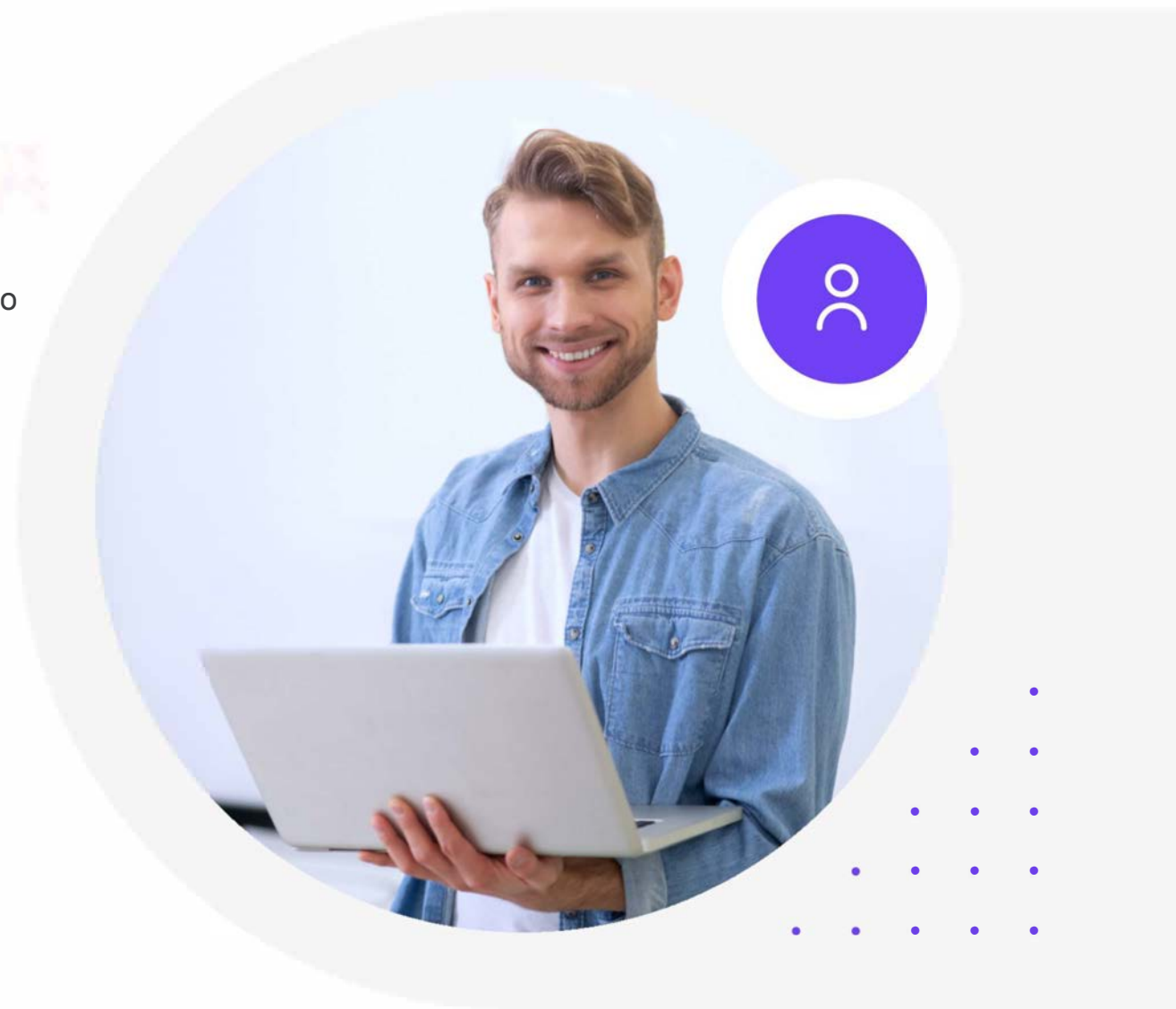
A key metric of our performance is our investment balance. We plan to end 2024 with \$100,000,000 worth of crypto assets.

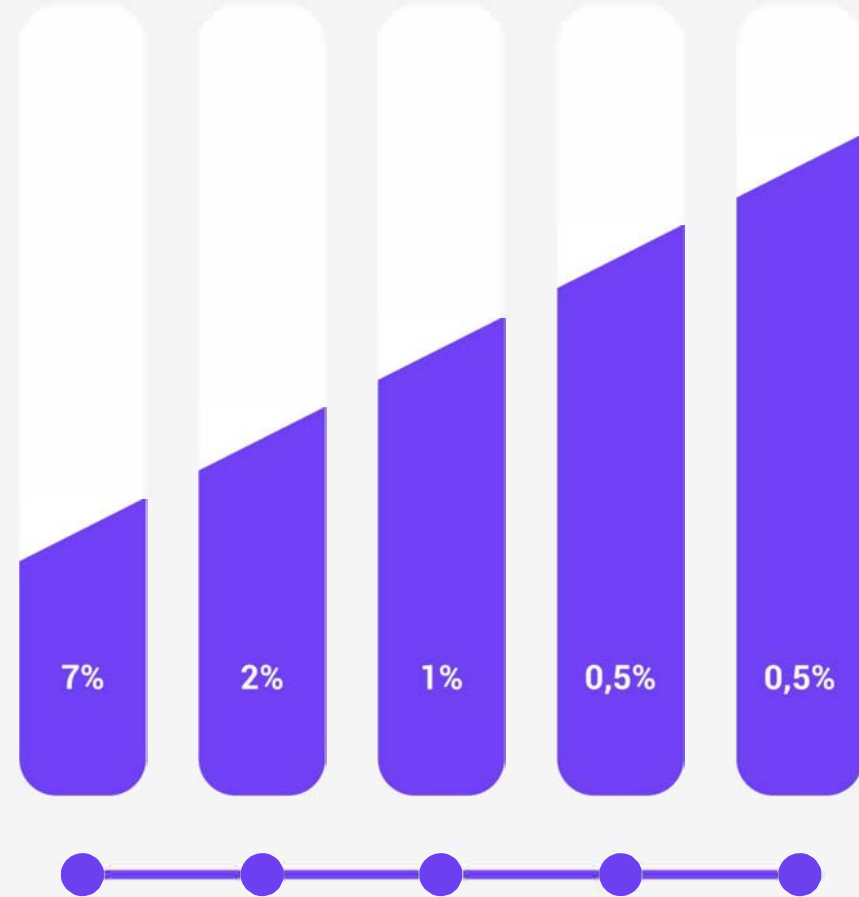
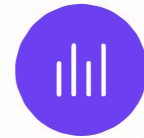
